The Global Fault-Line: Is Caucasian War with Negroids Plausible?

1. BACKGROUND

The recently published article, 'How Europeans evolved to have white skin, starting from around 8,000 years ago' (Loula and Eleftheriou, 2015), revives an age long controversy about genetics distinctions in the respective intellectual capacities of Caucasians and people of color (black/Negro will be used interchangeably). The credibility of this claim rests on three major symbiotic molds: The first is the strong believe in intellectual inferiority of persons of color - a core assumption of ideological racism, which is convenient, reassuring and a remarkably irrepressible myth. The second conjecture is religious or faith based. (Essentially, Islam and Christianity). This represents the Opium for the people; a sort of mind controlling tool. The third pillar is the politics of science racism, which relates to race and genetics. The first censure to claim by Caucasian to a superior intellect comes from the logic of time. Through the millennia for instance, there are historical fact that explains the liquid nature of group intellectual capacity or dominance - the dynasty or empire curve fully explains this trend. In this respect, and comparable to beliefs, it could be argued that intellectual capacity is transient, ephemeral and fleeting - an attribute that is constantly changing across time, space and genres. Human race is very much in its infancy and hence, it would be mental poisoning, a cognitive errors and logical fallacies to freeze intellectual capacities of a race in time. The cognitive bias that Caucasians promotes is an upshot of the luminous mind philosophy - a feature of human mind that must endure momentary defilements, like the Sun being obscured by the clouds. Sadly, this is far fetched due to greed, self-esteem and myopias. I know about (Ayeta) a situation that when the enemy fires certain bullets (missiles) at you, but will not even touch you while you have enough time to plot an escape. I know about certain applications, that when applied to your legs, snakes can never bite you even when you mistakenly stepped on it (antisnake bite). In the past Yoruba tribes know the secret to longevity and also through Ifa (Opele) (diagnostic material) they could accurately diagnose issues and predict the future and so on. All these and more were lost to Christianity. Such acts and people that embarked on them were seen as wizards, black magicians and it was deemed fetish. Africans were made to believe that only the blood of Jesus can save and you should reject in totality all form of self-help. Had we develop on these paths; perhaps, we could have found shorter way to go to planet Mars faster than the clumsy NASA methods as a whole. These accounts are well known and documented by few 'Ifa Priest' and some custodian of our cultures and traditions. That being said, Black Africans have achieved great heights in areas, which are deemed limited in scope due to forged historical facts. Before now, Black Egyptians were distinguished mathematicians, astrophysicist with high-level extra-planetary experience among others. It is still fresh that their scripts and discoveries were stolen and are today being slowly improved upon.

If for anything, why, would a 'race' deceive another into a set of believe about heaven and hell for purpose of control infinitum – or about marriage to some seventy-seven virgins, if they kill for God, whereby, they know better. While there are short-term gains, the long-term effect is simply too deep to envision. The importance of this question permeates time, space and race. Where do Caucasians originated? To approach this probe from racial point of view, would demean and over simplified and probably defeat the purpose of this enquiry. People of color must interrogate this sticky issue in order to regain the cognitive - from years of deceits and libels, fear, horror and trepidation. Further claim suggests that 40,000 years ago, the population in Europe were dark skinned; this is equally true of Australia, and New Zealand (The Aborigines). The white

population in this Oceania continent could not have been a patchwork of evolution? What transpire with the Aborigines or the people of color herein is still fresh – acquiring the right cognizance would mean an enquiry into what process, actions or actors erase all the chronicles of massacres, genocides and annihilations of the original people – how, and who guaranteed the mythos?

4. CAUCASIANS AND THE MYTH

It is stimulating to engage with the topical issue about the origin of the pale skinned people—where they came from and when? According to Loula & co, by comparing key parts of DNA across the genomes of 83 ancient humans from European archaeological sites with recent ones from the 1000 Genomes Project, Iain Matheison of Harvard University's lab of population, and geneticist David Reich, discovered the genes linked to skin pigmentation that had survived the natural selection process across Europe. The study went further to explain that the Africans that came to Europe lacked two genes – SLC24A5 and SLC45A2 – which lead to the depigmentation and lightening of the skin. But in the far north however, ancient bodies in Sweden from 7,700 years ago were found to have both these genes, and a third causing blue eyes, meaning 'they' were pale-skinned and blue-eyed.

There are other satirical accounts however, about this 'they' (fallen angels). While this may be sardonic, it is rational to adopt the alien parody. Ruminating deeply, and in retrospect - Hollywood effect or depictions aside, there are reasons to believe about aliens visiting the Earth and in some cases, we have been exposed to Hollywood version of what their motives were. Is war with Negroids conceivable? Up till now, proxy attempts have been observed and so far, more guns (AK47) have been ferried into Africa for the population to kill each other, yet the population is growing. All kinds of pharmaceutical industries have introduced microbes and all form of deadly viruses into Africa, it is working, but, perhaps, too slowly – a kind of speculation here: Seems like time is running out on something?

To direct our attention, we may examine the root cause of incessant and ongoing conflicts between the Caucasians, North Koreans and Persians that seems to have been around the earth long enough? Again, while we may not probe into where the Arabs originated from, we may want to examine why these population are pugnacious towards the Caucasians after the Peloponnesian wars, the battle of Solferino, the hundred year wars, WW1&11 that was predominantly fought amongst the Caucasians population itself? Notwithstanding a promising fifth generation counter-approaches to the Arab (mainly Sunnis) led terrorism; there is a deep and unsettling chasm that threatens to precipitate a new black conflict. The gulch is racial, the origins are manifold; it however, embraces the epoch of enlightenment brought about by Internet dialectics, and the 2016 electoral process in the United States.



I waved my right to call the regulating numbers to seek redress and simply waved down another cab, this time a Ghanaian Cab driver. Since this happenstance, I could not resist the urge to follow the political development in the United States for good reasons, until the 2016 episode. Sadly, xenophobia has heightened since Trump became the U.S. president. Poignantly, both Trump and Ivanka (First Lady) were migrants to the United State, and I sometimes mused about Ivanka being a KGB agent, I which case, the United States may be under attack already. The African Americans are also going through anxieties. "We are being hunted," Valerie Castile spoke about a black man in the wrong place. And so it makes sense that justice was not served for her son's murder from a "justice" system that works hand in hand with the police who do the hunting. The link to the CNN interview is, therefore, very instructive. It summarizes today's America, but fundamentally the Caucasian world. A system that would not hold accountable a white police officer who prejudicially killed Philando Castile in front of his girlfriend's four-year-old, on Father's Day weekend. Relatedly, and before making my conclusions, could God believably be Negroid?

6. IS GOD BLACK?

To defy the curio and inclination to probe into this subject is not only challenging and conflicting, it is also stimulating. This could be due to personal over exposure to the Bible teachings about what is good and evil as a young child. But, I took note of her conviction and complete disregard as she talk about Jesus in the like of a common criminal. It was a wistful feeling and I wonder if the creator of the universe is black? So I made decision to buy so many religious books on this trip and made some evaluations after going through some of them.

King Ramses and other characters from Egypt mythology were blacks, so was Moses, Aaron and the Jewish population that went through the Red Sea. Ramses II was the third pharaoh of the Nineteenth Dynasty of Egypt. He often is regarded as the greatest, most celebrated, and most powerful pharaoh of the Egyptian Empire. He was African in its writing, its culture and its way of thinking. Also, the Tribe of Levi is one of the tribes of Israel, traditionally descended from Levi, son of Jacob, or high priest of the Israelites. Moses and his brother, Aaron, were both descendants of the Tribe of Levi. According to accounts from the Virtual Jewish World, the Ibo of Benei Zevulun trace their ancestry to Jacob's fifth son, Zevulun. Tradition holds that a descendant of Zevulum named Zevulunu married Oji, a descendant of the tribe of Judah. Also, the Ibo of Benei Menashsheh are believed to be descendant from Meneshsheh (Menashe), the son of Joseph. Jacob's eleventh son. The Amichi, Ichi and Nnewi-Ichi ethnicities trace their lineage to Menashe. The tribe of Zebulun settled to the west of the tribe of Issachar, in the middle of the Galilee. Ibo's are dark skin people living in the south Eastern part of Nigeria. I went on a journey by road to investigate this claim-this section is being written in a village called Ovim in Isuikwuato Local Government area of Abia state, Nigeria. The people here are truly black people undeniably; a requiem for skeptic and importantly those that for centuries have been enjoying the deceits about the real characters in the book of Exodus. Todays' Jews in Israel and away, are probably Jewish by religion or alien impostors from another sphere. The Egyptians and Jews that we know today are pale skinned. I will like to conclude this article with 160-year-old Seneca story and the century old Jewish close call in Africa. First, in 1857, a Negro village called Seneca was destroyed to give room for today's Central Park in New York. Though the last of the Negro slaves wasn't emancipated until 1827 - the community began in 1825 and eventually spanned from 82nd Street to 89th Street along what is now the western edge of Central Park. Despite being a place of refuge for Negroid, it was razed down in 1857 by whites. About 46 years after Seneca, this time in Africa and in response to Theodor Herzl in 1903 - the British Colonial Secretary Joseph Chamberlin in a similar fashion to Seneca, offered 5,000 square miles for a Jewish settlement in East Africa. The location was at Gwas Ngishu on the top of the Mau Escarpment in Kenya. One may be inclined to ask-where did white Jews originated and when? What information do the British knew about this white Jews that inform their decision -why settle in Africa? After all, ancient Jews specifically, the descendants of Zevulum and Asher tribes are Negros.

It is thought that similarly displaced ancient Hebrews began to arrive in West Africa before 202 BCE, the date associated with the Nok civilization. Thus, Black populations do not have good memories of the Caucasians, not before, not at present and will not be in the future. White would continue to oppress Blacks and as an African, I could taste the feeling of this distaste. In the end, white tenacity and skewed proclivity for their creator and the creator of the universe would become their encumbrance–a repeat of the Tower of Babel.
